Description

Three modern steel portal framed industrial units of brick and insulated clad construction with a new insulated profile steel roof with inset roof lights. Each having an eves height of approximately 5.6m, each has a loading door of 3.4m wide, fitted with LED lighting and flourescent strip lighting, and each fitted with a small manager office, and separate w.c.

Location

Petersfield is situated 15 miles north of Portsmouth principally approached via the A3M and A3 and strategically located on the intersection with the A272 giving east to west communication to Midhurst and Winchester. Northwards the A3 continues via Guildford to the M25.

Amey Industrial Estate, is situated in Frenchman's Road, a very short distance from Bedford Road Industrial Estate and the mainline railway station. The town centre is approximately 5 minutes walk, and a similar distance to the railway station.
