The property comprises a 4 storey building of concrete frame construction faced in brickwork at ground level. The approximate date of construction is 1975. Internally, the property is configured to provide office space and cells for police use and will therefore require comprehensive refurbishment to convert it to an alternative use or would provide an excellent opportunity for redevelopment (STPP).

Fratton Police Station is situated on Kingston Crescent, a gateway site into Portsmouth. The site is ideally situated just off the M275 at the entrance to Portsmouth, located close to the Ferry port.
